THE EXECUTIVE DIRECTOR'S COMPENSATION IS REVIEWED AND DISCUSSED BY THE FULL BOARD OF DIRECTORS AND ANY COMPENSATION INCREASE IS PUT TO A SIMPLE MAJORITY VOTE. THE DECISION IS DOCUMENTED IN THE MINUTES OF THE BOARD MEETING. THE LAST COMPENSATION REVIEW TOOK PLACE IN JANUARY 2024.

COMPENSATION FOR OTHER KEY EMPLOYEES OF THE ORGANIZATION IS ESTABLISHED USING A SIMILAR METHODOLOGY AS THAT USED IN DETERMINING THE SALARY FOR THE EXECUTIVE DIRECTOR. COMPENSATION LEVELS ARE SET DURING THE BUDGET PROCESS. COMPENSATION INFORMATION IS OBTAINED FROM ONLINE RESOURCES, FROM OTHER NONPROFITS OPERATING IN THE WASHINGTON D.C. AREAS, AND FROM EMPLOYMENT AGENCIES SPECIALIZING IN NONPROFIT STAFF PLACEMENT.
